Your public records request seeking certain emails has been referred to me. Specifically, you requested the following information:

The City conducted a search using the above referenced search criteria and a total of ten e-mail messages were returned as responsive results. Of these ten emails, seven are disclosable to you. Code § 5-14-3-4(b)(6) because each contains intra-agency or interagency advisory or deliberative materials that are expressions of opinion or are speculative in nature and are communicated for the purpose of decision making. In addition, minor redactions were applied to one disclosable email to remove confidential financial information in accordance with Ind. Code § 5-14-3-4(a)(5) and an attachment to one disclosable email was removed to obscure information required to be kept confidential by federal law in accordance with Ind. § Code 5-14-3-4(a)(3) and 26 U.S.C. § 6103.

PROFESSIONAL SERVICES AGREEMENT

THIS AGREEMENT is made effective the 14th day of February 2025 between the City of South Bend, Indiana Venues Parks & Arts Department (the "City"), a Municipal Corporation organized and operating under the laws of the State of Indiana and Vivica A. Fox, Independent Contractor.

RECITALS

WHEREAS, the City, through the Venues Parks & Arts Department ("VPA"), promotes community engagement and dynamic experiences at the Century Center; and

WHEREAS, the City is celebrating the 10th Annual Black History Month Awards Ceremony and Reception; and

WHEREAS, the City is holding a community event; and

WHEREAS, the Contractor is a Professional Entertainer; and

WHEREAS, the City has determined that due to the Contractor's experience and expertise, it is in the best interest of the City to retain the services of the Contractor and to do so pursuant to the terms of this Agreement in support of the Black History Month Awards Ceremony and Reception.

NOW THEREFORE, for and in consideration of the mutual covenants and promises contained herein, the City and Contractor hereby agrees as follows:

Section 1. Duties of the Contractor and City

The Contractor will be present at the 10th Annual Black History Month Awards Ceremony and Reception from 6:00 p.m. – 8:00 p.m. on Thursday, February 20, 2025 at the Century Center. The program may go over by 30-45 minutes due to pictures. The Contractor has agreed to share brief remarks regarding the importance of Black History Month, celebrating with her hometown of South Bend and more.

At all times during the performance of their services under this Agreement, the Contractor shall adhere to the highest degree of professionalism, technical skills and standards.

Section 2. Consideration.

The total consideration under this Agreement shall be Twenty - Five thousand dollars (\$25,000) paid directly to contractor, plus First-Class Round-Trip Airfare, a two-night hotel stay in South Bend, and a personal driver. The driver will be in a SUV. These accommodations also are included for the Contractors Manager. The Contractor has agreed that the entire payment of twenty-five thousand dollars (25,000) will be due after the signing of this contract by both parties and upon arrival on February 19th (photo of cashier's check will be sent to contractor's manager). A payment in the amount of three-hundred dollars will also be included paid directly to Contractor for the Contractor's Driver in Los Angeles to and from the Airport.

The Contractor has agreed to accept full payment at once and if for any reason or circumstance that the Contractor is unable to attend any of the events, the City is entitled to a Full Refund of \$25,300.

The Contractor agrees to participate in a reasonable number of media interviews to promote the event and to post on Contractors social media promoting the locations experienced during the stay in South Bend.

Section 3. Term and Termination.

This Agreement shall commence on February 17th, 2025 ("Effective Date") and shall end on February 21st, 2025 ("Expiration Date"). This Agreement may only be extended by mutual written agreement of the Parties.

Section 4. Changes in Scope of Services.

The Contractor understands and agrees they shall not commence any additional work or change in the scope of the work unless authorized in writing by the City. No claim for additional compensation shall be made by Contractor in the absence of the prior written approval of the City.

Section 5. Governing Law; Compliance with Laws.

This Agreement shall be construed and interpreted in accordance with the laws of the State of Indiana. Any disputes under this agreement which cannot be resolved by the Parties shall be brought in a court of competent jurisdiction in St. Joseph County, Indiana.

The Contractor agrees to comply with all applicable federal, state and local laws, rules, regulations in performing their services under this Agreement.

Section 6. Relationship/Independent Contractor.

The relationship of the Party hereto is that of independent contractors. The Party hereto are not deemed to be an agent, partner or joint venturer of the others for any purpose as a result of this Agreement or the transactions contemplated thereby. The City shall provide IRS Form 1099 to the Contractor, if applicable.

Section 7. Entire Agreement.

This Agreement sets forth the entire agreement and understanding between the Party as to the subject matter hereof, and merges and supersedes all prior discussions, agreements, and understanding of any and every nature between.

Section 8. Counterparts and Electronic Signatures.

This Agreement may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Agreement, and all of which, when taken together, will be deemed to constitute one and the same agreement. The electronic signatures of the

Party shall be deemed to constitute original signatures, and facsimile or electronic copies hereof shall be deemed to constitute duplicate originals.

Jordan,

The City of South Bend's Annual Black History Month Awards Ceremony & Reception is an event that I look forward to every year. I have many friends and mentors who have been honored in years past, and ones, such as you Jordan, who are being honored in this year's award ceremony. This being its 10th anniversary, makes it more special and important that we work together to make this a successful event.

There are two documents that I have requested in multiple emails, but have not yet received, since the first email Amy sent to the VPA Foundation on Tuesday, February 11th, 2025, in her original "ask" for \$25,000.00 to pay Ms. Vivica A. Fox to come to South Bend.

- An electronic copy of the fully executed signed contract between Ms. Vivica A. Fox and the City of South Bend
- A document that has the itemized list of donors, which includes each of their pledged dollar amounts, their expected due dates, and an electronic copy of their invoices.

On Wednesday, February 12th, 2025, Amy sent a copy of the unsigned contract, which isn't legally binding, and doesn't give us any assurance. (Please see attached.)

I've had multiple conversations with my board members who are concerned that we have not been provided a copy of the fully executed signed contract between Ms. Vivica A. Fox and The City of South Bend. Without a binding legal contract, we don't have any assurance in case if for some unsaid reason, (i.e. weather, illness, etc.), Ms. Vivica A. Fox is not able to attend, we have no recourse in getting our money back.

I don't understand what the hold up is on your/the City's end to send those two necessary assurances to Brandon, Kevin and I. I had hoped to have those two necessary assurances last week so that I could approve this and move forward on this. To have the majority vote, we needed 7 Yes's, and we only had 6 Yes's. My Yes will give us a majority.

Again, I request that you send the following items to us this morning:

- An electronic copy of the fully executed signed contract between Ms. Vivica A. Fox and the City of South Bend
- A document that has the itemized list of donors, which includes each of their pledged dollar amounts, their expected due dates, and an electronic copy of their invoices.

I look forward to receiving this requested information, so that we may move forward to make

this happen by noon today.

Lastly, in anticipation that these requests will be met, in terms of the changes. The original agreed upon contract amount was for \$25,000.00, plus the recently added \$300.00 for transportation to and from the airport in California. Therefore, the cashiers check should be made in the amount of \$25,300.00, not \$26,300.00.

It is the VPA Foundations understanding that in addition to the \$25,000.00 appearance fee, and the \$300.00 airport transportation in California, the VPAF will be separately invoiced for the following:

- Shuttle service provided by McGhee Services in the amount of \$1,000.00
- 1st Class round trip tickets for (2) United Airlines in the amount of \$2,403.94
- Food for the Event, (Awards Ceremony & Reception)-Frankies BBQ & Linden Grill- \$4,000.00

All of which will be paid when the donations for this event come in, or reimbursed to the VPA Foundation once those donations are received. Please confirm.

I look forward to making this happen today. Please send the requested items in order to do that.

Beth —

The necessary assurances regarding the City of South Bend's 10th annual Black History Month Awards Ceremony & Reception have been met. The decision to deliberately hold off on the wire transfer with questions that do not align with the bylaws is beyond inefficient and unproductive. All required information was included in the initial proposal, and the city officials reviewed and approved the contract with

Vivica A. Fox. As previously shared, the money will be paid back within a reasonable time, so there won't be any loss.

Shay Davis, a representative from the mayor's office, dedicated an hour on Friday evening to address the manager's concerns. This was necessary to prevent Ms. Fox from withdrawing from the agreement due to apprehensions about not receiving her reimbursement. As a result of the discussion, we are required to obtain a \$26,300.00 cashier's check instead of proceeding with a wire transfer. The check must be acquired by noon EST and placed in the possession of Shay Davis for her to send a photo to the manager as evidence of our commitment. Additionally, an extra \$300.00 is being allocated for Ms. Fox's transportation to and from the airport in California, serving as an additional demonstration of good faith.

I'm surprised by your questioning of the integrity of my staff and the Mayor's cabinet, given that this event has been ongoing for a decade. Regrettably, you encounter red flags in your perception, as Venues Parks & Arts consistently upholds high standards and fiscal responsibility. Even with potential indecisiveness and an abstained vote, half a dozen Foundation board members reached a majority decision.

It's important to proceed with the best approach as soon as possible to ensure the success of the upcoming awards ceremony. I'd humbly request that we expedite the requests and that the bankers verify if it can occur tomorrow. I believe the holiday does not impact this process, so I strongly encourage you to proceed with haste.

I am looking forward to a successful event on Thursday.

Amy-

We will not be sending the wire transfer today. I talked to 1st Source this afternoon, the wire cut off was at 3:30 P.M. today. Monday is President's Day, a Federal Holiday, and the Federal Reserve is closed. The earliest that Brandon & I can transfer the money is on Tuesday morning, February 18th.

As of now, we do not have the majority of the votes from the board to approve the \$25,000.00, (\$12,500.00 prior and \$12,500.00 on the day of arrival) fee to Vivica A Fox, or the additional \$7,403.94 for the related expenses.

As previously mentioned to you, before I voted favorably towards this, I needed additional information, such as a copy of the executed contract, verification that a city attorney has reviewed and approved the contract between Vivica A. Fox and the COSB, the name of Vivica A. Fox's Agent, and his contact information, an itemized list of donors, funds promised and expected date of receiving those funds into the foundation, in order for me to make an informed decision to say Yes without reserve. After multiple requests, you have not provided me with that information. You have given me vague answers, and no executed contract, which doesn't suffice. Had you given me the information that I requested, I probably would have voted yes, and I would have been able to make the transaction happen today.

In all honesty, by not being forthright, you are throwing too many red flags that are causing me to question the validity of this contract with Ms. Vivica A Fox. Once the money is wired, there is no turning back. If this is potential fraud, then we have no recourse, and it falls on Brandon and I, and not on you, Shay, Jordan or on the City of South Bend.

Therefore, until I receive this information from you, I will wait to vote. Hopefully, you will send me the information requested so that I may make an informed decision to vote favorably, and we can make this all work out. In which case, Brandon and I can meet at 1st Source and send a partial payment of \$12,500.00 first thing on Tuesday morning.


